Directions for Use	<p>For shock treatment when irrigation lines are clogged or there is visible slime build-up use IRRIGATION LINE CLEANER at a rate of 1 gal per 1,000 gallons of irrigation water. For best effect, hold product in irrigation lines for up to 12 hours and then flush to remove foreign material.</p> <p>For bi-weekly treatment to inhibit slime or hard water build-up, use this product at a rate of 1 gallon per 3,000 gallons of irrigation water. Contain product in the line for 12 hours and flush irrigation system to remove foreign material.</p> <p>For continuous treatment to inhibit slime or hard water build-up, inject this product at a rate of 1 gallon per 20,000-40,000 gallons of irrigation water. Dose at this rate continuously to provide effective and long-lasting water treatment.</p>
