



## Drain-Ex Tabs (DBNPA Tablets)

<b>Applications</b>	A deodorizer used in treating drains in manufacturing or other food establishments.										
<b>Properties</b>	Drain-Ex Tabs incorporate 2,2-dibromo-nitrilopropionamide (DBNPA) along with Enviro Tech's proprietary slow-dissolution technology allowing each tablet to last for 2-3 weeks. Tablets are packaged individually in water-soluble bags to allow for safe handling, and are suitable for use in contact with stainless steel drains, or suspended in bags in non-stainless drains – tablets will not swell or leave any slimy residue.										
<b>Chemical Composition</b>	Drain-Ex tabs are composed of 95.6% DBNPA, with the balance a proprietary inert package providing controlled release.

<b>Shelf Life</b>	Product and packaging will remain effective for one year if stored properly. After this time, water soluble film may begin to degrade, but tablets will remain effective.										
<b>Packaging</b>	5.5 lb polyethylene pails, 4 pails per box. Pails are 6-quart.
