Essential Duties and Responsibilities include but are not limited to the following:

- Ensure Daily Plant Quality and Food Safety Operations are in compliance with Enviro Tech policies, procedures, customer requirements and local state and federal regulations.
- Lead in the implementation of SQF, HACCP, Food Defense and FSMA Programs.
- Drive continual quality improvement as measured by internal and external audits.
- Directly monitor daily activities of employees to ensure adherence to company quality requirements while providing leadership, guidance, and training (as needed).
- Supports management and operations with technical quality and food safety expertise to investigate and troubleshoot any issues related to food safety and quality.
- Write and develop plant SOPs which pertain to quality systems.
- Possesses a high degree of initiative, attention to detail, flexibility, and ability to change priorities quickly to meet the needs of the business.
- Administer or oversee workflows for quality changes (MOC).
- Ensure compliance with all regulatory and customer food safety and quality requirements.
- Oversee the development, implementation, review, and maintenance of the SQF Systems, including food safety fundamentals and the Quality Plan.
- Conduct monthly quality meetings.
- Complete Annual SQF system review as a team with all locations.
- Responsible for ensuring annual drills, challenges, 3<sup>rd</sup> party testing are completed as required to uphold the SQF system.
- · Responsible for conducting external SQF audits.
- Responsible for all reported quality concerns to ensure corrective actions are in place to effectively mitigate further issues.
- Communicates with sales people regarding any complaints, investigations, and resolutions.
- Assist regulatory for all local, state, federal and third-party food safety and quality audits, Kosher Certification, and any inspections.
- Quality manager assumes the responsibilities designated to SQF Practitioner.
- Quality Assurance Unit for GLP Studies.
  - o Maintain copy of a Master Schedule which includes all studies conducted.
  - o Inspect studies at intervals adequate to assure the integrity of the study. Review the final study report to assure that it accurately describes the methods and SOP's and that the reported results accurately reflect the raw data of the study.
  - o Maintain written/signed records of each periodic inspection and submit written status reports of each study to management / study director.
  - Prepare and sign a statement to be included with the final study report that specifies the dates of audits and dates of reports to management/study director.
