

**Precautionary Statements:**

**Response**

Typical use rates are 0.5-4oz/gallon. 1oz/gallon (1:128) is recommended for routine slime and scale removal. If heavy cleaning is required 2-4 oz/gallon (1:64 - 1:32) solutions are recommended

Inject into system using a common medicator

Uncap the system at its furthest point and check for effervescence to ensure solution has complete coverage of the system

Activate all drinker nipples or cups

Circulate when possible. If circulation is not possible, hold the solution in the system for 12-24 hours

When cleaning is complete, thoroughly flush entire system with potable water

It is recommended to use an EPA registered animal drinking water sanitizer/disinfectant continuously when animals are present
